





2016 ANNUAL REPORT TO STAKEHOLDERS

The Commission on Dental Accreditation of Canada (CDAC) is a partnership with membership from the public and organizations representing oral health care professionals, educators who prepare them and regulators responsible for their competence and continuing safe practice. CDAC, in consultation with its partners, develops and approves requirements for educational programs preparing dentists, dental specialists, dental interns/residents, dental hygienists and dental assistants. CDAC also develops and approves requirements or standards for institutional dental services. CDAC reviews educational programs and dental services by means of structured, on-site visits following receipt of submissions presenting detailed information in the required format. Programs and services meeting or exceeding the requirements are granted accredited status.

The CDAC 2016 meetings were held in Ottawa, Ontario on November 19 to 21, 2016.

INFORMATION ITEMS

Report of the Documentation Committee

In 2016, no items requiring CDAC action were discussed.

The Documentation Committee directed CDAC staff to revise the current process for requesting changes to accreditation requirements from stakeholders. It will now require including background information, rationale, and supporting documentation, prior to circulation of the changes for comment.

Following conversations regarding the renewal of the national competencies for a beginning practitioner, a sub-committee to review DDS/DMD accreditation requirements will be created. The Committee recognizes that this process will likely be conducted over a two-year period (2017-2018).

The Committee also considered a request from the Canadian Dental Assisting Regulatory Authorities (CDARA) regarding the accreditation of dental assisting expanded activity training modules (Orthodontic and Restorative). The Committee agreed this request should be explored further and that a Sub-Committee be established to review and investigate the CDARA request.

Report of the Finance Committee

CDAC 2015 detailed financial information was circulated to all CDAC stakeholders

2017

Dental Clinics of the Canadian Armed Forces

During the November 2016 Commission meeting, CDAC approved a motion to conduct accreditation survey visits of the Canadian Armed Forces dental clinics. This will represent survey visits to 25 dental clinics, conducted over two weeks in 2017 (April and June).

International Activities

The CDAC Chair and the Director will be attending the International Society of Dental Regulators (ISDR) Annual Conference in London, UK (October, 2017).

Following the ISDR Conference, considering the reciprocity agreement signed in 2012 between CDAC and the Dental Council of Ireland (DCI), the CDAC Chair and the Director will be participating in the survey visit conducted by DCI in Cork.

The CDAC Chair and the Director will also be attending the Commission on Dental Accreditation of the American Dental Association (CODA) meetings in August, 2017.



Accreditation Software

Work will begin in 2017 to identify a company and to start the development of a new CDAC accreditation software aimed at creating efficiencies in the accreditation process.

2018

In 2018, CDAC will be conducting, with the help of a facilitator, a thorough strategic planning exercise with the objective of creating a strategic plan to guide CDAC activities and relationships with stakeholders.
