Thank you, Gord. This I appreciate and understand.

In my discussions, on a hypothetical case, with Johnson Shoyama Graduate School of Public Policy, such circumstances are challenging, and a high level report, within the scope of the NDA should be possible.

The representatives around the table should, in such a situation, make a case for issue. A stand-alone may be discounted, but the group should be in a position to create reasonable expectations within the scope of intent of the NDA.

It is absolutely worthy of a discussion at the Governance Committee, and also to look at how best to frame for such occasions in the future. In this case, I was challenged for our President and CEO/Executive, for the situation they encountered, and the information came quite late in the process for any valuable and important input by Council. There is, I offer, an opportunity for staging, not discounting the second larger NDA that was defined.

I hope this helps to frame the discussion I offer is not only important for ensuring we remain within the expectations as a governing body, but also within timing to ensure appropriate address of issues of significant important (and risk) to its members and the public.
