
Executive Summary


- Details of the Canadian Dental Care Plan were released in February 2024. In collaboration with the CDA, all PDA's invited their members to provide their reaction to the details.
- Canadian dentists express a limited level of support of the plan coupled by limited level of interest in participating. The level of opposition is double that which was reported in the initial reaction survey.
- On aggregate, the most common reason given for not participating is the administrative burden. Common secondary reasons are the lack of clarity on how it will work with the Provincial programs, the Benefit Grid not being similar to the current Suggested fees and the requirement to sign an agreement.
- The very few who say they are likely to participate would balance bill the patient for the difference.


Level of Support or Opposition


- Over 7 in 10 dentists oppose the Plan overall with 45% having feelings of **strong** opposition.
- This is double the initial reaction recorded in December of 2023 when limited details were available.
- Differences are evident by province, where dentists in Manitoba and Nova Scotia dentists are more likely to be opposed overall (circa 9 in 10) and primarily **strongly** opposed.
- Those who have a high level of understanding of the program, are more likely to be opposed than those who do not.
- Similarly, those who are newer to practice (under 20 years) are more likely to be opposed than those who are more seasons (over 20 years).



By Province










Likelihood to Participate

- Similarly, about 7 in 10 are unlikely to participate in the Plan.
- Those from Manitoba and Nova Scotia are more **unlikely** to participate than elsewhere.
- Those who understand 'a lot' are much more unlikely to participate than others.
- The likelihood of participation doesn't vary by years in practice or size of community.











Reasons for Not Likely to Participate

- The most common reason given for not being likely to participate is the administrative burden.
- Secondary reasons are lack of clarity on how it will integrate with provincial programs, the Benefit Grid not being the same as provincial fees and the requirement to sign agreement.
- Those in small cities or rural areas are more likely to say than other areas that the reasons are the lack of clarity with provincial programs and a lack of capacity.



Balance Billing and Participation Level

- Among the very few who are likely to participate in the Plan, about 7 in 10 are likely to balance bill the patient for the portion not covered by the plan.
- Also, among the few who are likely to participate, the most (about 6 in 10) will see any patients who present, and offer any services that are required.

• Among all respondents, if they were required to decide at the time of the survey, the majority would NOT participate in the Plan.

Activity Undertaken

- 65% have reviewed the CDCP Benefit Grid and 60% attended or watched a Town Hall from their own association.
- Those who are newer to practice were slightly more likely to review the Benefit Grid than those who had been in practice for over 20 years.
- Just about a quarter to one third have reviewed the Claims Processing and Payment Agreement.

Contact with Sun Life

- About 4 in 10 had been contacted by Sun Life and primarily by mail. Most were neutral (67%) and about a third (28%) were left with a negative impression of the contact.
- Those who were contacted by phone are more likely to have a negative reaction than those who were contacted by email or mail.
